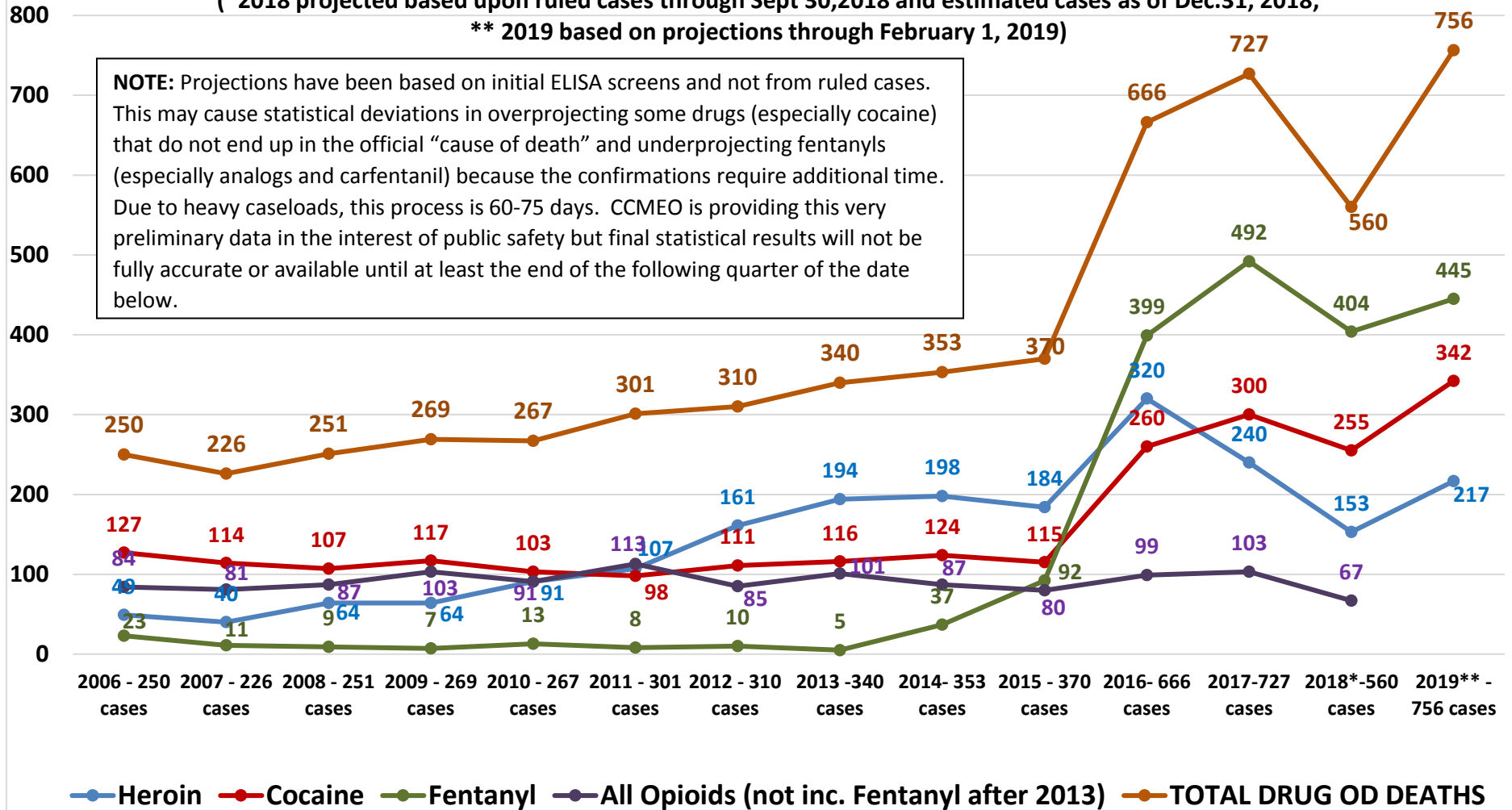

Cuyahoga County Overdose Deaths 2006-2019**

Most Common Drugs

(*2018 projected based upon ruled cases through Sept 30,2018 and estimated cases as of Dec.31, 2018;
** 2019 based on projections through February 1, 2019)

NOTE: Projections have been based on initial ELISA screens and not from ruled cases. This may cause statistical deviations in overprojecting some drugs (especially cocaine) that do not end up in the official "cause of death" and underprojecting fentanyl (especially analogs and carfentanil) because the confirmations require additional time. Due to heavy caseloads, this process is 60-75 days. CCMEO is providing this very preliminary data in the interest of public safety but final statistical results will not be fully accurate or available until at least the end of the following quarter of the date below.

CURRENT PUBLIC HEALTH EMERGENCY – At least 1 fatalities since Feb. 1

Fatal Cases due to heroin/fentanyl/analogs in JANUARY– at least **58 (3 cases pending testing)**

30 - City of Cleveland Residents

24 - Suburban Residents- Broadview Hts., Brook Park, Cleveland Hts., East Cleveland, Euclid, Fairview Park Garfield Hts., Lakewood (2), Maple Hts. (3), Mayfield Hts. (2), Newburgh Hts., North Olmsted (2), Olmsted Falls, Parma (3), Seven Hills and Westlake and,

VICTIMS

Victims' ages range from 20 - 80

44 Male victims; 14 Female victims

16 African American victims; 42 Caucasian victims (3 hispanic victims)

TRENDS

At least **58** victims have died from heroin/fentanyl/analog or in combination through January 2019. This compares to 37 in 2018 and 52 in 2017 for the worst January on record. 2019 total is at least **62** fatalities when including cocaine as well.

Carfentanil: 56 FATAL CASES in 2016; 191 in 2017; 24 confirmed fatal cases in 2018 as of 2/1/19

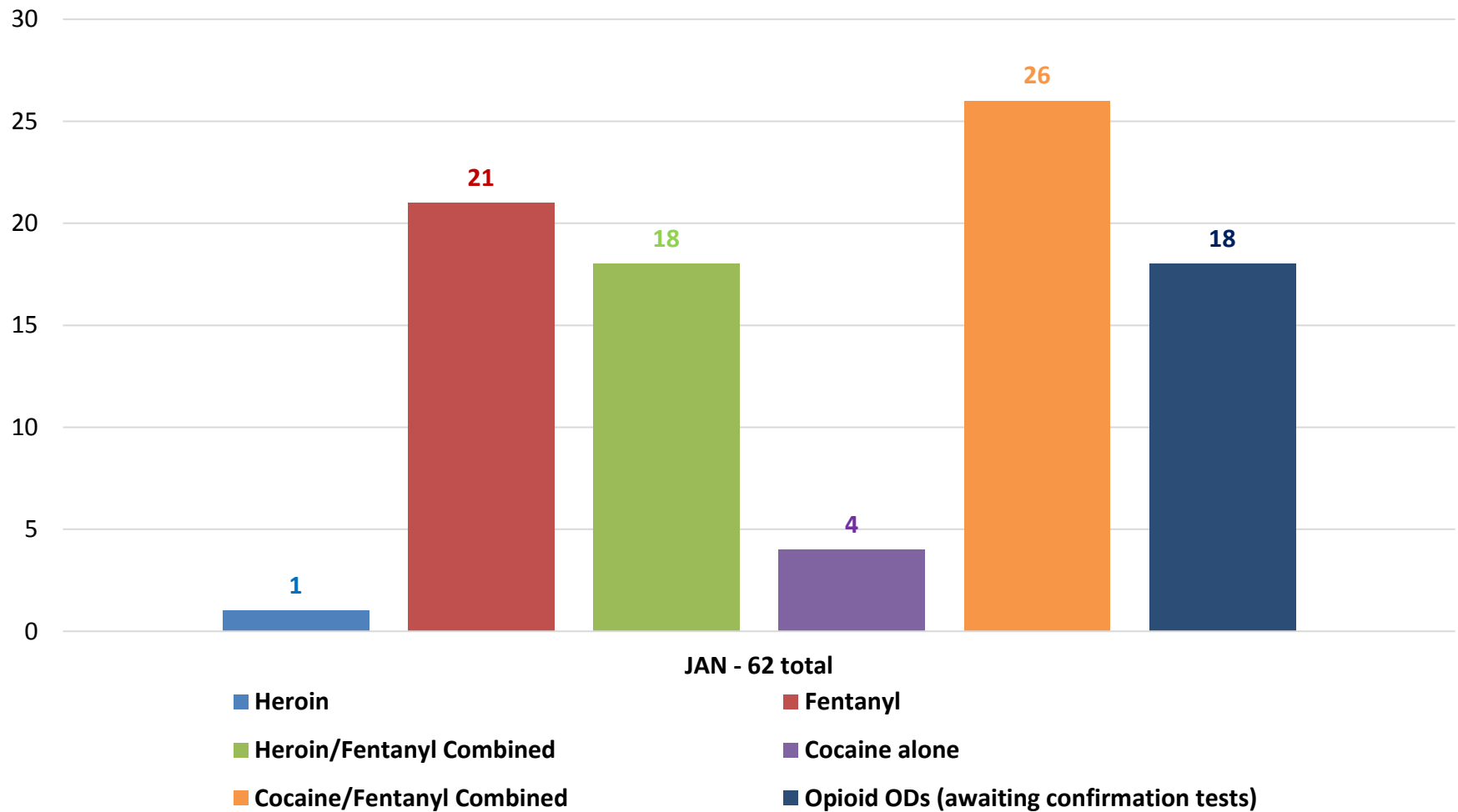
Rate of African American deaths involving fentanyl is 27.56% of all victims so far in 2019, a rate above 2016 (14.5%), and higher than the 20.33% in 2017 and 21.11 in 2018. As many as 30 cocaine related deaths occurred in January 2019 with as many as 26 being mixed with Fentanyl, Heroin or both.

Combined is heroin and fentanyl in some combination (Fentanyl analogues will be counted under Fentanyl Columns).

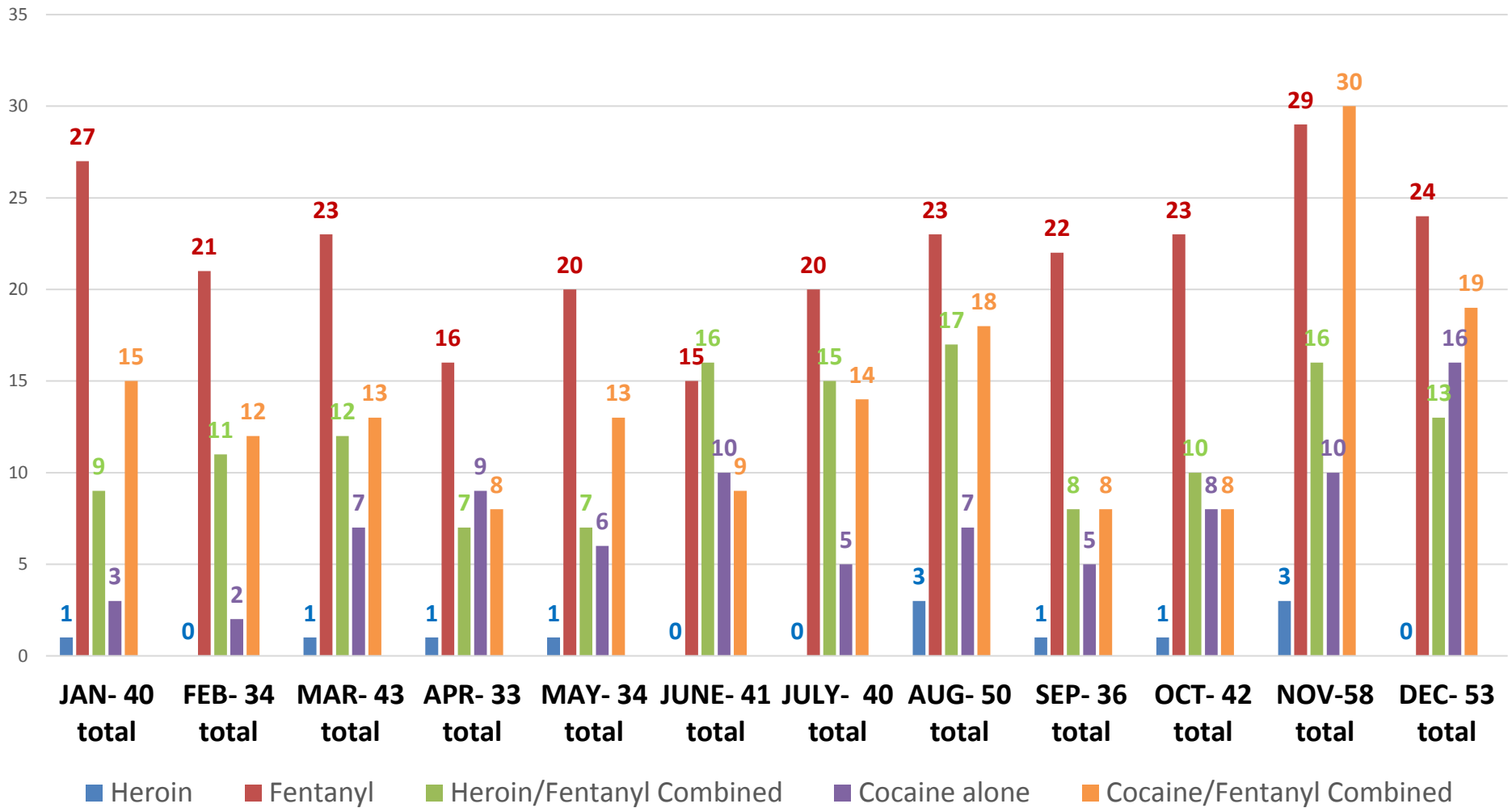

Combined is heroin and fentanyl in some combination (Fentanyl analogues will be counted under Fentanyl Columns).

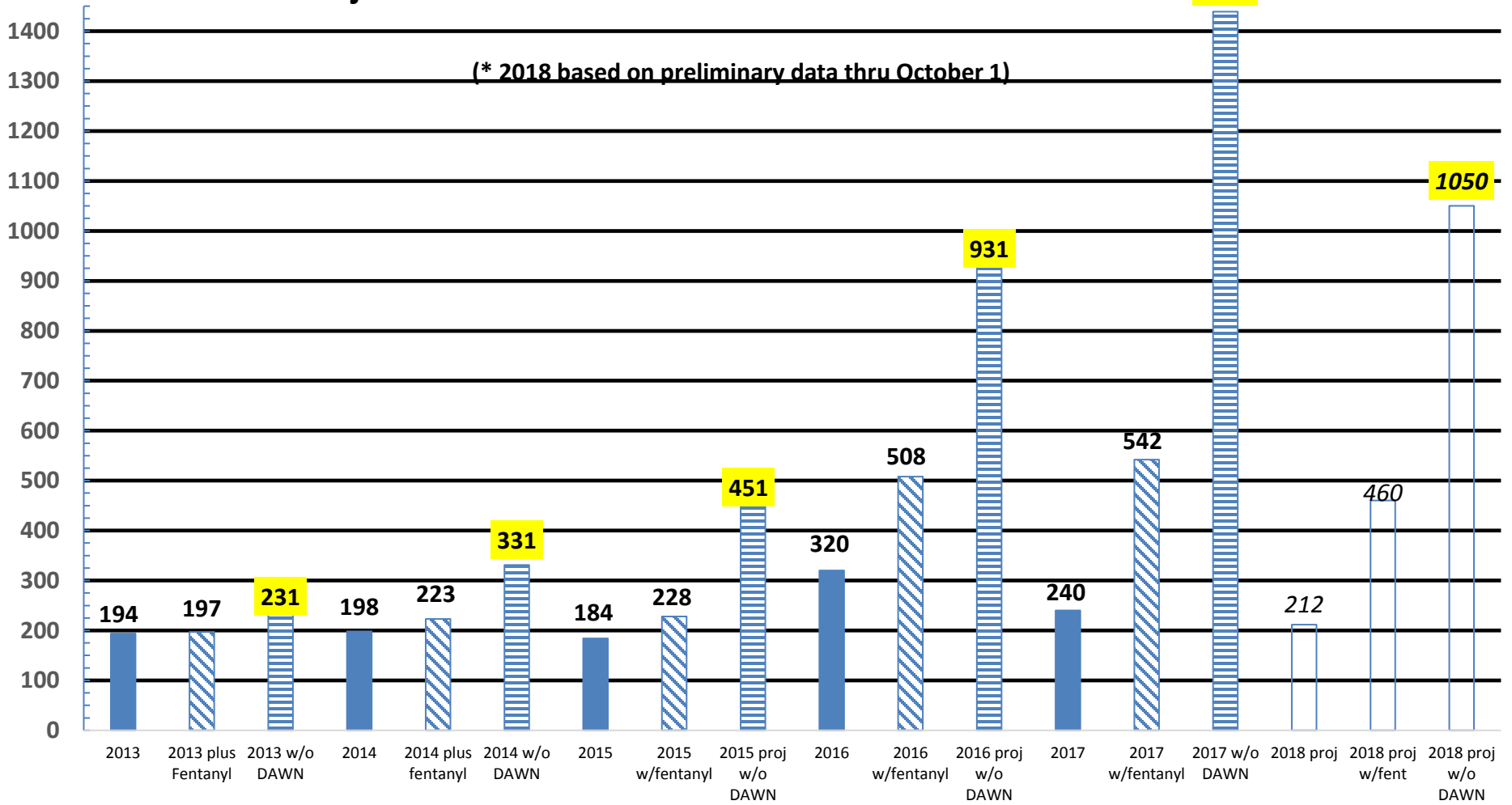

Projected deaths with DAWN Saves as overdose Deaths 1439



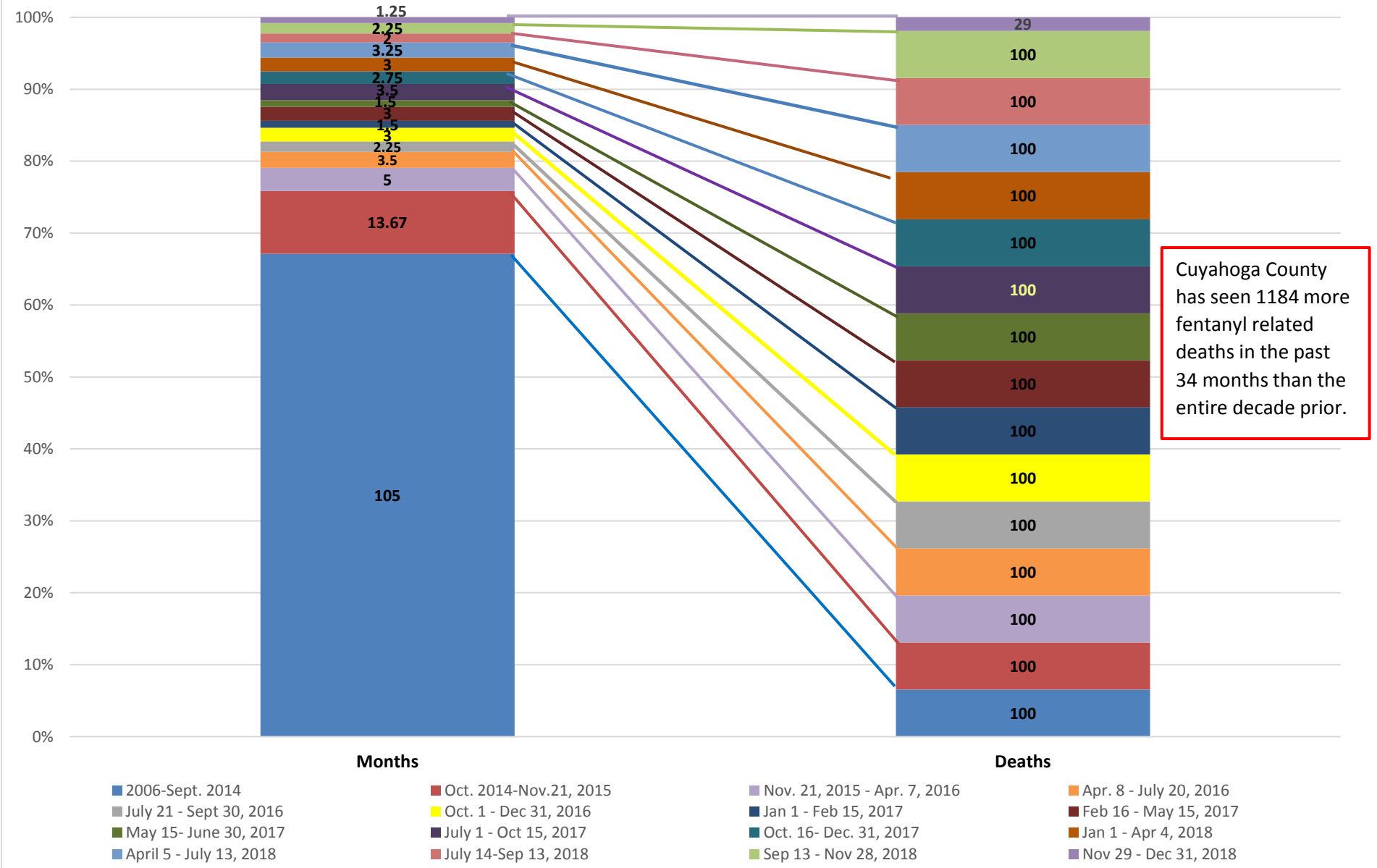

Cuyahoga County Fentanyl Deaths 2006-2018



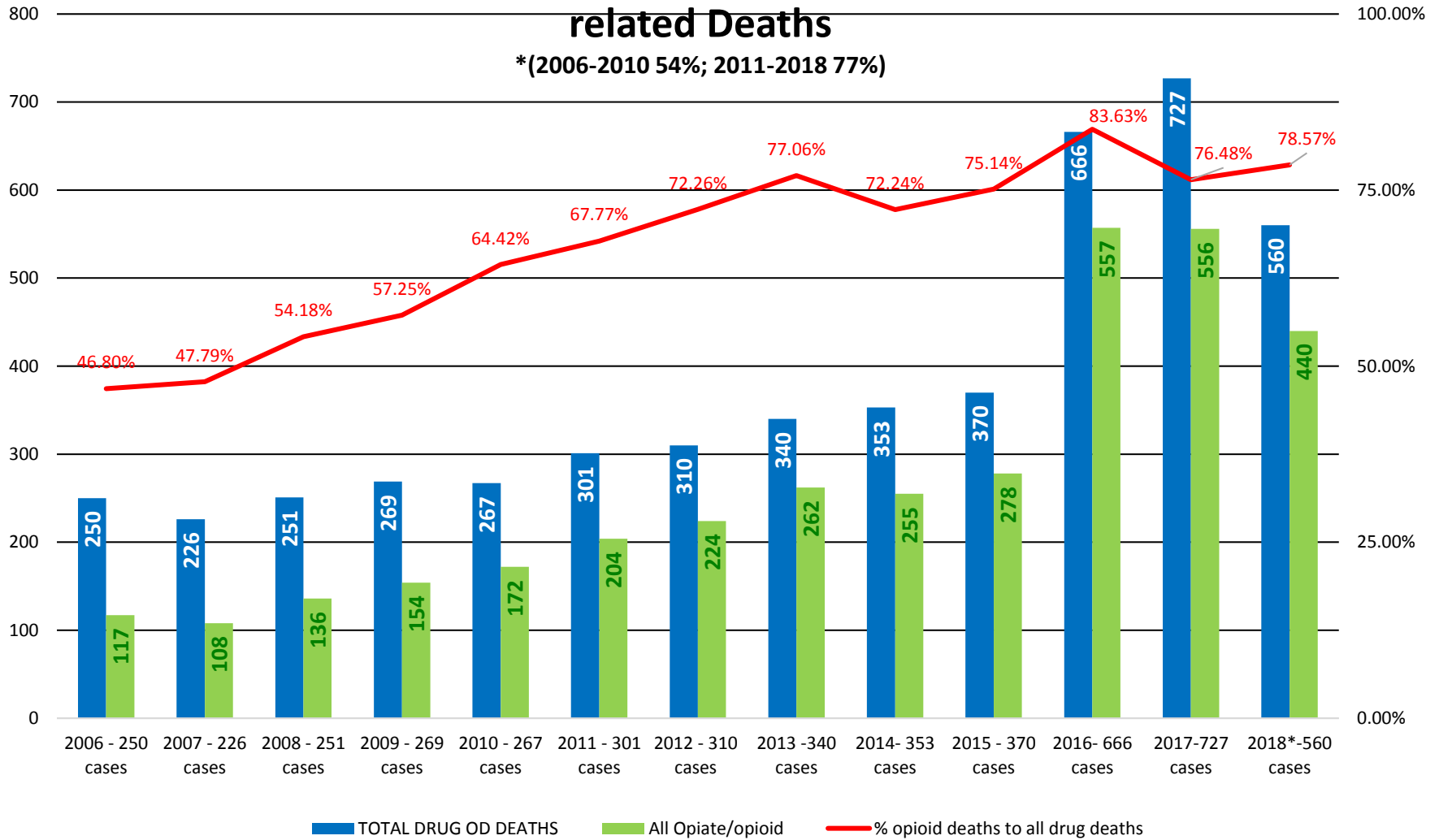
Cuyahoga County has seen 1184 more fentanyl related deaths in the past 34 months than the entire decade prior.

*(2006-2010 54%; 2011-2018 77%)

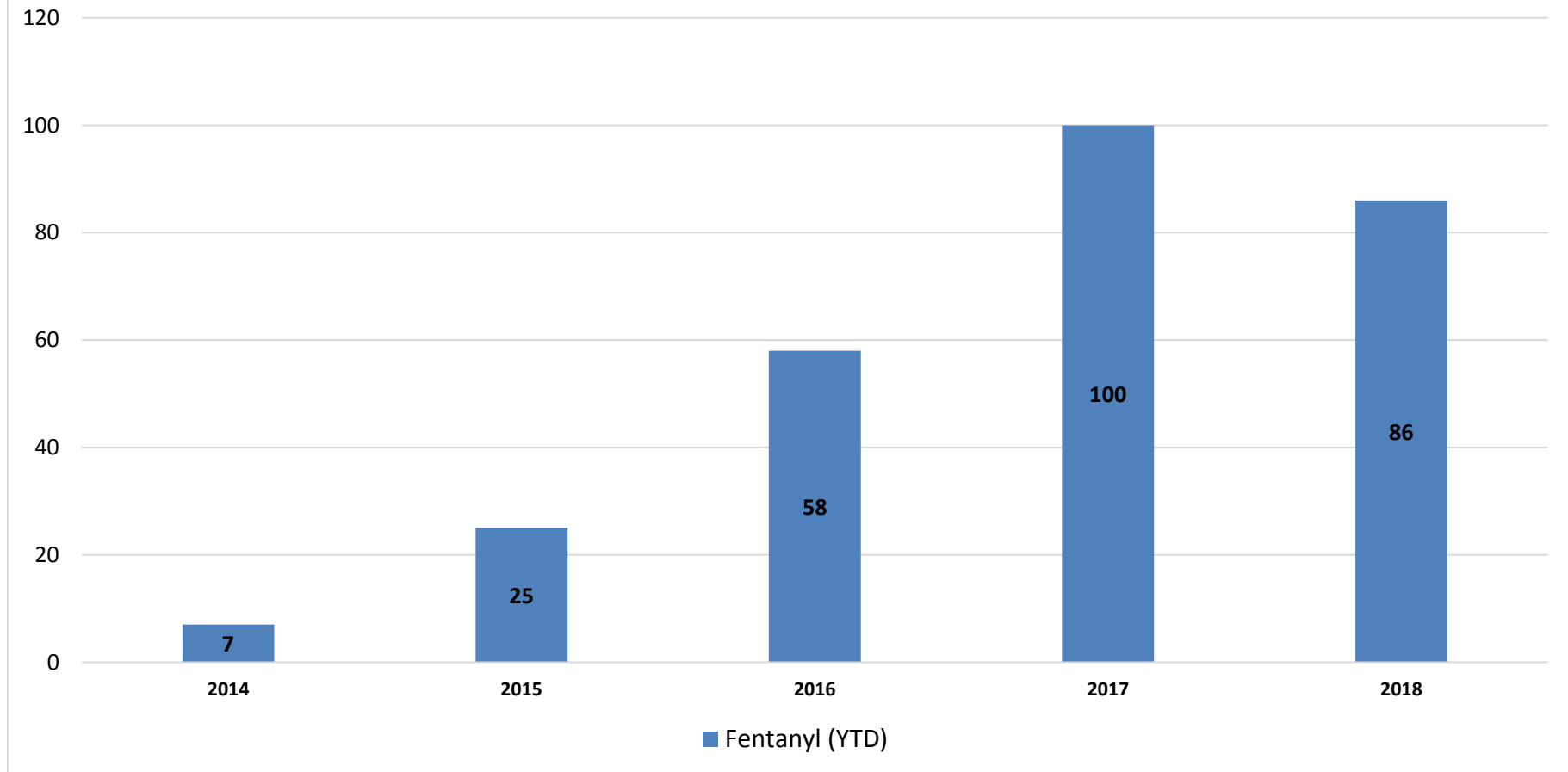

CCMEO Fentanyl-related fatalities among African Americans 2014-2018*

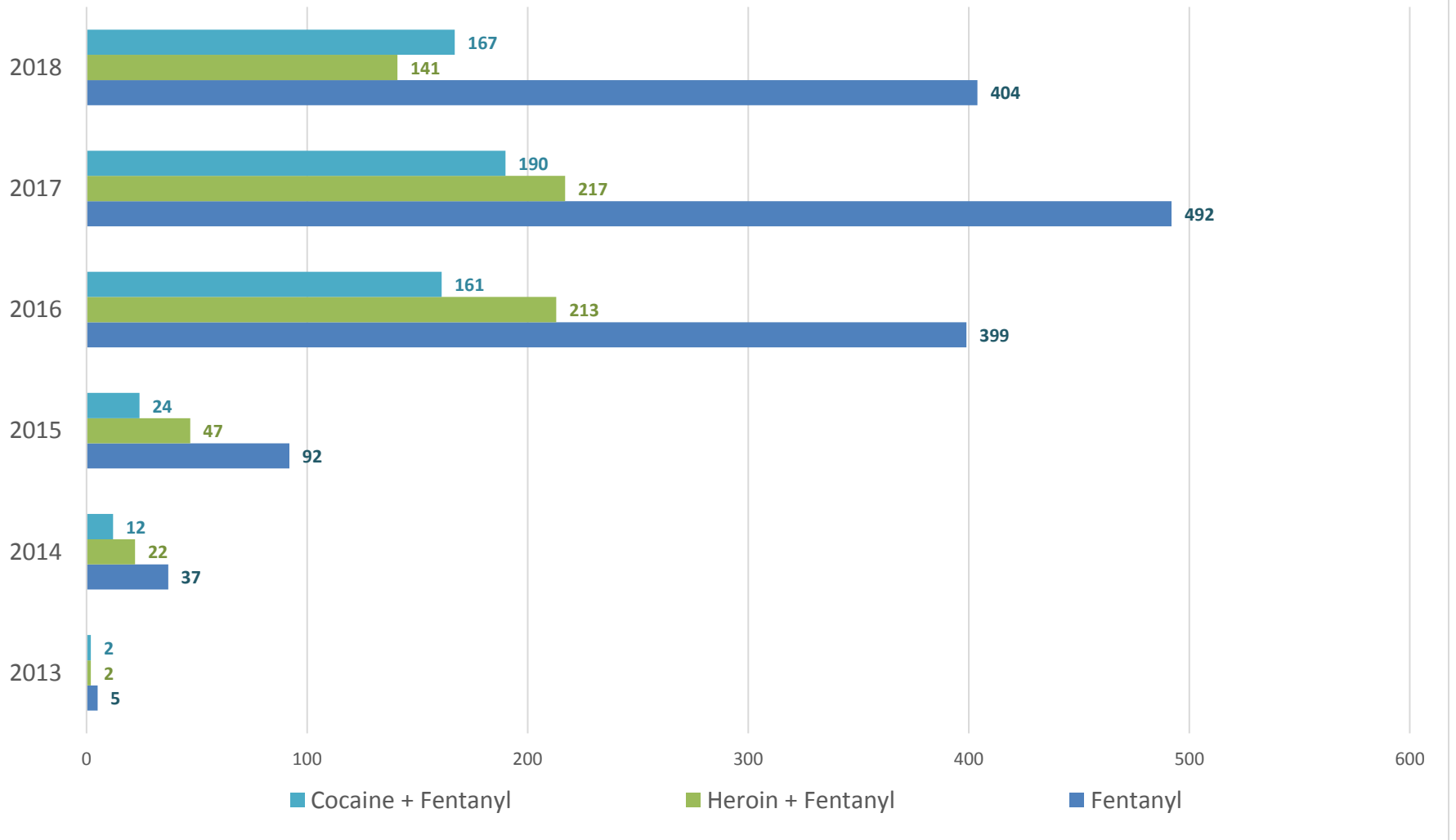

2013-2018* (* through December 31, 2018)



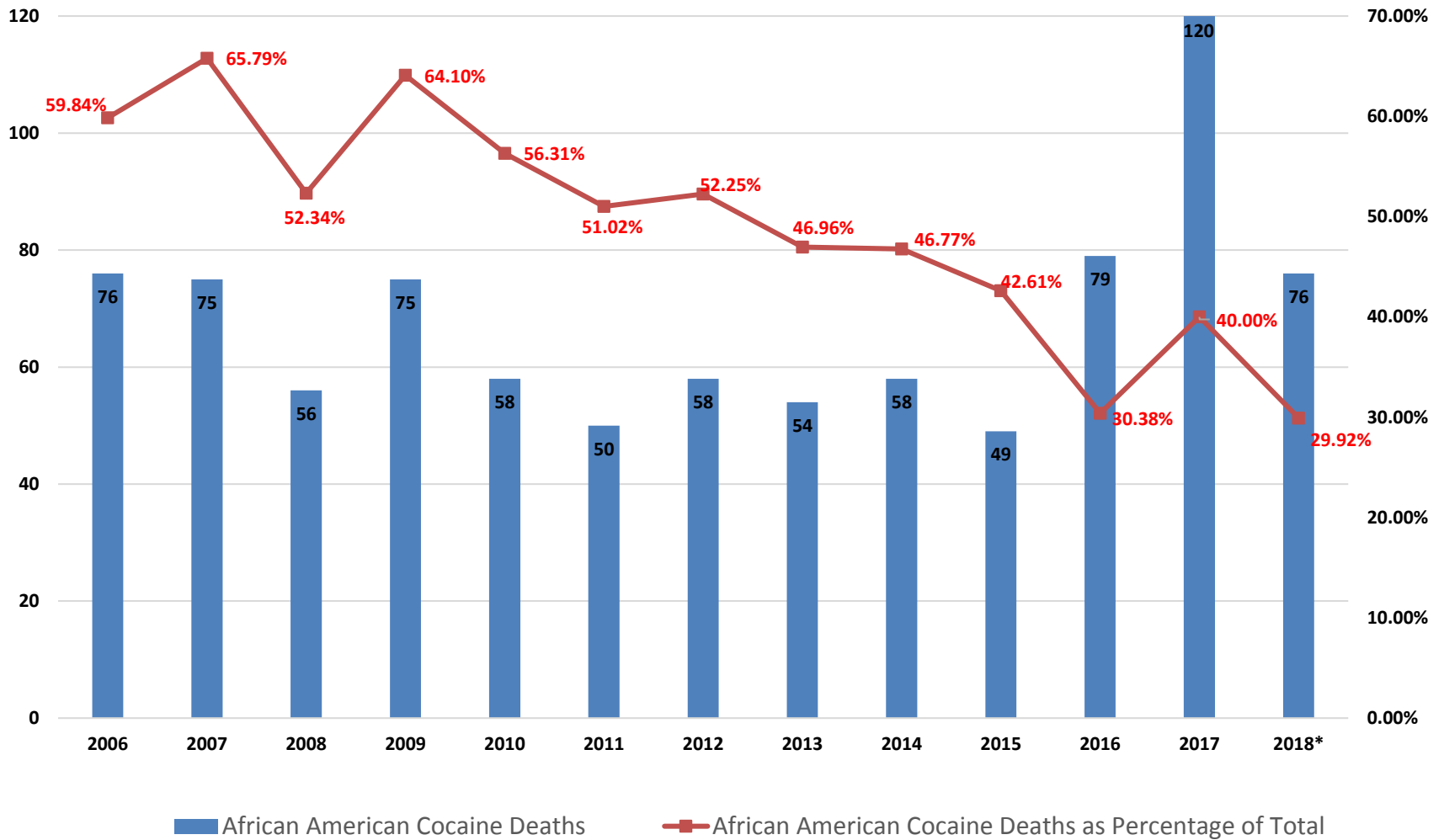

Demographic Shift in Cocaine Deaths (Includes cocaine/fentanyl mixed cases)

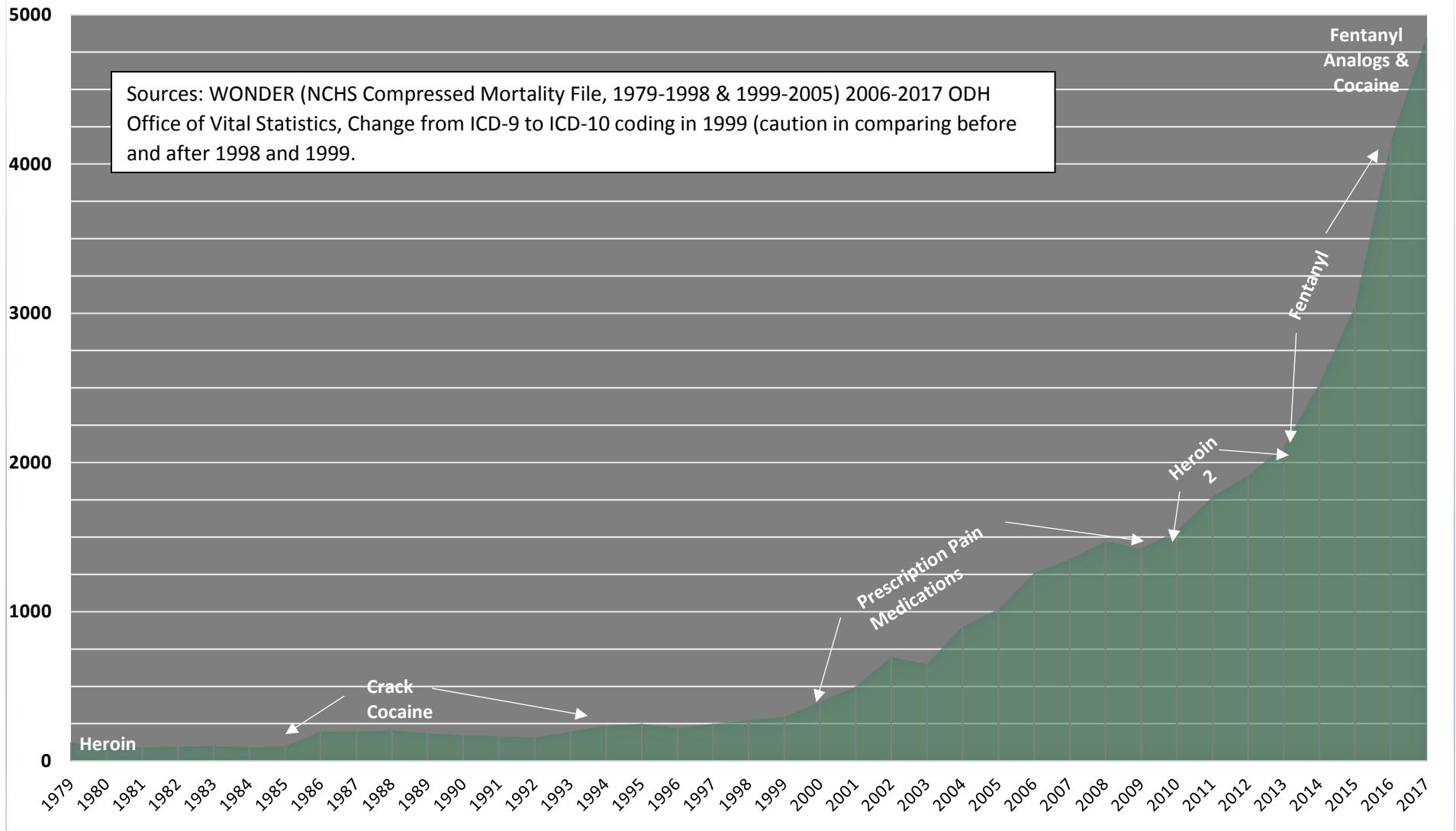
